## 第一章 總則

第二條 本會之組織，由會員大會（臨時會員大會）、理事會、監事會及辦事處等組成。會員大會（臨時會員大會）為本會之最高權力機關，由全體會員組成。理事會為本會之執行機關，由會員大會（臨時會員大會）選舉產生。監事會為本會之監督機關，由會員大會（臨時會員大會）選舉產生。辦事處為本會之常設工作機構，由理事會任命。本會之辦事處設於本市某某路某某號。

第三條 本會之會員，應為具有完全行為能力之自然人。凡具有本市戶籍，且符合本會章程規定之條件者，均可申請加入本會。會員之權利包括：（一）選舉權、罷免權、創制權、複決權；（二）對本會事務之監督權；（三）對本會經費之管理權；（四）對本會章程之修改權；（五）對本會之廢止權。會員之義務包括：（一）遵守本會章程；（二）繳納會費；（三）維護本會聲譽；（四）協助本會辦理各項事務。
